



transnational funding projects beetwen LuFo and Take Off

- TAKE OFF/LuFo Calls 2007 2014
- Joint info days
- Funding is being provided for a period of 3-4 years
- 5 project funded so far, more projects in the contract negotiation phase
- Combined overall funding budget of approx. 36 Mio EUR, shared between LuFo (German Aeronautic Programme) and TAKE-OFF (Austrian Aerospace Programme).

*****AirTN first transnational call for proposals 01/2012


Austria, Ireland, Spain and Sweden

4 proposals submitted, 2 proposal approved, 2 proposals funded

*****AirTN second transnational call for proposals 01/2013

Austria, Ireland, Italy, Spain and Sweden

4 proposals submitted, 2 proposal approved, 1 proposals funded

No trans-national flows of national funding





Alternative => Eranet cofund H2020: aviation

ERA-NET Cofund: implementation of a co-funded joint call for proposals (compulsory, one co-funded call per Grant Agreement)^{*}

Air Transport Net

EU contribution: proportional contribution to total public funding of the joint call

Stable reimbursement rate: ERA-NET Plus reimbursement rate from FP7 (33%) applies

Additional EU contribution to coordination costs on the basis of a unit costs for additional activities including additional calls without top-up funding

Co-funded calls: proposal evaluation and selection according to Horizon 2020 standards

* ERA-NETs based on a Coordination and Support Action (CSA) are no longer possible. Only in exceptional cases it might be considered to support the preparation and structuring of specific emerging P2Ps that demonstrate clear European added value.
