#### **1. Mode of Operation of ACARE MSG**



- To provide up-to-date information on the ACARE activities, the Strategic Research and Innovation Agenda (SRIA), as well as latest aviation research plans and results to Member States representatives.
- To ensure proper feedbacks from the group and the incorporation of Member States in the most important ACARE activities.
- To provide the Member States position on strategic issues dealt within ACARE and to give feedback to the other ACARE bodies on various ongoing activities
- To provide a forum to discuss aviation related issues including those on the agenda of the Horizon 2020 Programme Committee Transport Configuration which have strategic importance.
- To enhance communication between the ACARE bodies and the H2020 Programme Committee – Transport Configuration representatives.



- Within ACARE, 5 working groups and ACARE MSG should provide envelope over the whole activities
- ACARE MSG is supposed to direct efforts of national states within this respect
- ACARE MSG is to help in harmonizing efforts in many activities within ACARE
- ACARE MSG is to support various national stakeholders in the innovation / research activities

#### **3. Opportunities and Threats**



- ACARE MSG supports transnational cooperation this is one of the core premises of its existence
- The main obstacle (politics-wise):

Why do we need dedicated transnational calls if we can collaborate within Horizon 2020, Clean Sky 2 and similar ones

#### • The main dilemma:

How to overcome significant difference / difficulties appearing in different countries when organizing transnational cooperation



• Countries with **developed aeronautical sector**:

the potential and possibilities are significant - dedicated funding for aviation and transnational cooperation through joint calls is much easier to establish

• Countries with no dedicated funding for aviation:

the transnational cooperation through dedicated calls is not so easy - necessary to create political climate first and then start the creation of joint financial instruments (e.g. pure research where substantial financial resources are a must)



- To **increase research coordination** among countries through activities in regional and transnational cooperation (joint calls)
- To acquire data on regions that are prospective in aviation R&I and assist in best practice transfer to the less successful ones (regions or Member States)
- To **improve mechanisms for decreasing R&I discrepancies** among member states (transfer of best practices)
- To support transnational research coordination with other fields of research, indirectly related to aviation (e.g. IT, energy)

### 6. Goals – TC in Harmonisation Activities



- To improve harmonising in educational system covering primary and secondary education, apprenticeship, academia and lifelong professional development (complementarity with WG5)
- To contribute in harmonisation of R&I environmental activities at the level of member states
- To provide R&I activities aimed at seamless inclusion of UAS/ UAV into the commercial airspace and through joint calls harmonise legislative framework for their use
- To support **R&I activities required for door-to-door international transport** (especially taking into consideration the multimodality aspects) within member states, when transnational aspect is included (what is the case most of the time)



- To establish activities and review achieved results within complex multinational aviation related CSAs (e.g. currently AirTN Nextgen) aimed at R&I
- To coordinate activities on existing and future aviation related JTIs (e.g. currently Clean Sky 2) aimed at more efficient use of financial resourced
- To promote the importance of the SRIA objectives at the level of individual Member States



- To help more efficient activities on R&I within various new emerging initiatives (e.g. biofuels, paperless documents, big data, cyber-safety and security)
- To help harmonizing potentially incompatible requirements among various countries, thus creating positive climate for future multinational activities
- To actively encourage Member States in joint procurement of research and test infrastructure – connection to existing ESFRI\* process and similar emerging initiatives, as well as SFs such as ESIF
